The KCFM Jury Committee has arranged for all Artisan vendors to attend the annual jury sessions for approval of items sold in the market. Since this is the first year of a new policy, all Artisans must have their products juried this year. Then, returning vendors will be juried every three years.

Jury Dates: The following dates have been set to jury market products. All returning vendors, as well as any new vendor, need to attend the March 12th or 19th dates. If you cannot attend either of the March dates, please arrange a time on April 2nd to be juried. Please arrive at the assigned set-up time given below. Any new items can be juried at the jury dates listed below by appointment with the Jury Committee Chairperson, Beth Bender at 509-929-6986.

Jury Process:

Vendors will receive an application by mail, or may download an application from KCFM web site. Please fill out the application and bring with you to the jury session. This will be turned in as you enter, with remittance of the \$10.00 jury fee. Please use the Craft Categories sheet to determine which Jury time to attend. If you have items from multiple categories, please attend the Arts/Crafts Variety session. Submit a sample of your work that is representative of EACH item that you intend to sell in the KCFM. Jewelers are advised to bring a display board or tray with jewelry tightly secured. Each craft vendor will be juried using the Handcrafted Art Criteria Sheet. At least 3 judges will appraise your items, and then the totals will be reported to the board. The board will then determine the Market Vendors for the year, with the remainder on a wait list. Vendors will be notified by mid-April of the results.
